Through the interactions and observations made by the Peer team it has certainly drew our responsiveness to specific areas that require special focus to improve upon. Further, she said that the college has been re-accredited with 'B' Grade, securing 2.62 CGPA out of 4. The validity of III Cycle NAAC A & A will be valid for five years upto March 28, 2021.

IQAC and NAAC Steering Coordinator Dr. Manohar S. Joishi Kumble shared the important recommendations suggested by NAAC Peer Team for quality enhancement of the Institution. The members took note of the same and directed towards working on it.


